APPEAL FOR OFFERINGS TO SUBSIDIZE THE 2008 CONFERENCE COSTS.

Greetings in the very precious name of our Lord Jesus Christ.
The 2008 National Conference comes up as follows:-

DATE: MARCH 19TH- 23RD 2008.

VENUE: NATIONAL (ECUMENICAL) CHRISTIAN CENTER, ABUJA

As has been the practice since 1989 when the first conference held, brethren coming for the conferences paid for their personal expenses (accommodation, food, etc), but such facilities common to all had been funded through subsidy offerings- where brethren who are believed to be in a position to afford beyond their basic conference fees are given the opportunity to give offerings to take care of such common facilities.

Such common facilities that come under subsidy offerings include:-

1. RENTING VENUE OF CONFERENCE FOR 5 DAYS
2. PROCURING/HIRING PUBLIC ADDRESS SYSTEMS
3. PROVIDING BASIC PUBLICITY FOR THE CONFERENCE
4. SUBSIDIZING THE CHILDRENS' CONFERENCE FEES
5. SPONSORING BRETHREN FROM MISSION FIELDS FOR CONFERENCE
6. CONFERENCE SECRETARIAT MANAGEMENT EXPENDITURES
7. PROVIDING **LIVE** INTERNET BROADCAST OF THE CONFERENCE
